- ☑ April 20th, 2018 (Fri.)
Deadline to receive posters if author is not attending the Conference.

Abstract and Poster Submission Procedure:

- The abstract must be 300 words or less. Submit the abstract at <http://www.excipientfest.com/index.php/schedule/poster-sessions> on or before **April 6th, 2017**. If you need to include tables and/or graphics please email them to marisol.perez@excipientfest.com.

Poster Guidelines:

- All posters will be displayed during both days of ExcipientFest. Posters will be set-up and completely dismantled by authors. If author is not able to attend, ExcipientFest will mount and dismount the poster.
- Poster set-up: April 24th (Monday) 4:00PM-10:00PM / April 25th (Tuesday) 6:00AM-10:00AM. Poster take-down: April 26th (Wednesday) after 5:00PM.
- No electrical projection capabilities will be available. All items for posting must be prepared in advance.
- Poster board is 6 feet wide by 4 feet high. Mounting surface (usable space) is 5'10" wide by 3'10" high
- You are responsible for supplying your own materials for mounting posters. Only thumb tacks or pins allowed.
- ExcipientFest will assign your poster a number, please setup your poster at the space with the number assigned to you.

Fees:

- **Exhibitors: \$150 per poster**
- **Non-exhibitors: \$300 per poster**
